



2. Mounting of ACU to wall
3. Installation of soft drawn copper tube as standard specs (0.28" thickness) required by unit.
4. Installation of thick rubber insulation for all copper pipes.
5. Lay-out of standard wiring requirements of units – indoor to outdoor.
6. Wrapping up of required polyethylene tape (white) on the insulations and flexible wire conduit.
7. Installation of required circuit breaker housing and accessories.
8. Installation of indoor and outdoor units (mechanical and electrical).
9. Leak testing.
10. Observation of parameters (temp. pressure, etc.)
11. Turn-over.
