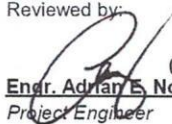

Considering the above conditions, we regret to inform you that we cannot guarantee the efficient performance of unit. Also, One (1) year warranty for parts (compressor-10year).

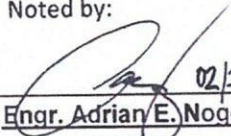

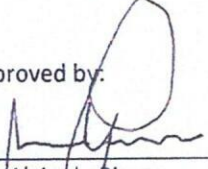

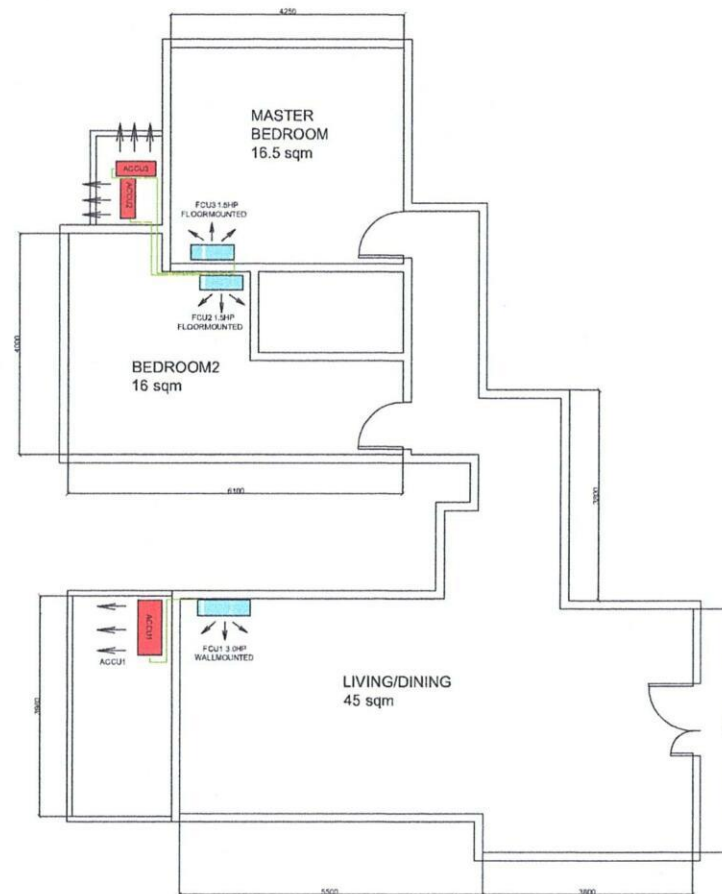
